

Keynote Address:
Dr. Michael Carpenter
"Current threats and challenges to the European project"

Thursday, April 6, 2017 6:00-7:00 PM Hampton Room, 2nd Floor, Malott Commons Cosponsored by the EU Center of Excellence, University of Washington

Dr. Michael Carpenter is Senior Director of the Biden Center for Diplomacy and Global Engagement at the University of Pennsylvania. Dr. Carpenter is a former Deputy Assistant Secretary of Defense with responsibility for Russia, Ukraine, Eurasia, the Balkans, and Conventional Arms Control. Prior to joining the Department of Defense, Dr. Carpenter served in the White House as a foreign policy advisor to Vice President Joe Biden and as Director for Russia at the National Security Council. Previously, he was a career Foreign Service Officer with the State Department, where he



worked in a number of different positions, including Deputy Director of the Office of Russian Affairs, Speechwriter to the Under Secretary of Political Affairs, and Advisor on the South Caucasus. Dr. Carpenter also served abroad in the U.S. Embassies in Poland, Slovenia, and Barbados. During his career at the State Department Dr. Carpenter received four Superior Honor Awards and three Meritorious Honor Awards. He holds an M.A. and Ph.D. in Political Science from the University of California at Berkeley and a B.A. in International Relations from Stanford University. Dr. Carpenter was a Fulbright Scholar at the Polish Academy of Sciences and has received fellowships from the American Council of Learned Societies, MacArthur Foundation, and IREX Foundation for his academic research.



Keynote Address: Dr. Adam Zientek "A Historical Perspective on Refugees in Europe: International Humanitarian Aid During the First World War"

Adam Zientek is Assistant Professor of History at the University of California Davis. He studies the social and cultural history of war in the 20th century, with a specific focus on the Western Front during the First World War. His current project, Wine and Blood: Alcohol, Discipline, and Morale in the French Army on the Western Front examines the French army's use of alcohol as a tool of social control.

Conference Volume Publication

Best papers will not necessarily be selected from each panel; rather, papers will be evaluated in reference to the larger pool of all conference papers. The conference volume is now published in both print and online format through the Claremont Colleges Digital Library, which allows greater dissemination of the selected papers – the publication comes up in searches through databases like WorldCat.
