**Articulation Agreement  
for Transfer  
from Marymount College  
to Scripps College**

Women accepted for admission to Scripps College from Marymount College will be eligible for junior class standing when they have completed a minimum of 64 transferable semester units. Marymount College women who have maintained a B (3.0) average or higher in at least 32 transferable units are encouraged to apply.

*Women completing the **Phi Theta Kappa Honors Program** at Marymount College as part of at least 64 transferable semester units are recognized as well-prepared and are **guaranteed priority consideration** for admission to Scripps College at the junior level.*

**Transfer Credit Limitations**

1. A maximum of 64 transferable semester units (equivalent to 16 Scripps courses) will be accepted from Marymount College for transfer to Scripps College.
2. Courses graded “C” or higher (not including “C-“) will be accepted for transfer.
3. Courses passed on a Credit/No Credit basis at Marymount College will count only as elective credit toward the bachelor’s degree requirements and will not meet any General Requirements or major requirements at Scripps College.
4. Grades for transfer courses will not be used in computing the Scripps College cumulative grade point average.
5. Those courses at Marymount College identified in the Marymount College Catalog as being transferable to the University of California (UC) without limitations **and** offered in academic disciplines also offered at the undergraduate Claremont Colleges (Claremont McKenna, Harvey Mudd, Pitzer, Pomona and Scripps Colleges) will be accepted as transfer credit. (Courses identified in the Marymount College Catalog as being transferable only to the California State University will not transfer.)

Transfer credit will **not** be granted for: Anthropology 140; Business 110; Communication Arts 101, 118, 125, 130, 140, 145, 200, 250; Computer Science 180; Education; English 118; Geography except 108 or 108H with 108L; Health Education; Interdisciplinary Studies 107, 117, 130; Mathematics 107, 115; Music 155; Physical Education; Psychology 200, 205, 220, 225, 240, or 280—unless preceded by Psychology 150 or 150H; Speech; Theatre Arts 100, 170-177.

Courses in any discipline numbered 290, 291, 295, or 296 will only be considered for transfer credit by petition.

6. Transfer credit for Advanced Placement and International Baccalaureate will be considered separately as defined in the Scripps College catalog upon presentation of official scores and high school transcripts. Transfer credit from a Marymount College transcript for credit earned by examination or military experience will not be accepted by Scripps.
7. Applicability of transfer credit to meet requirements in the student's major will normally be limited to introductory courses and will normally be considered only as prerequisite to the major.
8. Transfer credit earned as semester units at Marymount College will be converted to Scripps College courses based upon one semester unit being equivalent to one fourth (.25) Scripps course. One Scripps course is equivalent to four semester units. Any individual Marymount course equivalent to three semester units or more may be considered to meet a specific requirement at Scripps.

**Applicability of Marymount College Courses  
toward Scripps College General Education Requirements**

English 112 required; English 114 strongly recommended

**First-Year Writing Requirement**

Transfer students will be placed into the Core sequence based upon their class standing at entrance. Students who transfer with the equivalent to 4 or fewer Scripps courses will begin with Core I and complete the 3-course sequence. Students who transfer with the equivalent to 5-8 courses will complete Core II and III. Students who transfer as first-semester sophomores (8-12 courses) must complete only Core III. Transfer students entering Scripps with the equivalent of 12 or more Scripps courses will be waived from the Core Curriculum requirement.

**Core Curriculum in Interdisciplinary Humanities**

***Fine Arts:*** One 3-unit transferable course from Art (but not Art History), Music (except 165), or Theatre Arts; and

**Breadth of Study (one course in each of four areas)**

***Letters:*** One 3-unit transferable course from Art History, English Literature (but not English 114, 115 or 116), Philosophy (except Philosophy 130), or Religious Studies; and

***Natural Sciences:*** One 4- or 5-unit transferable course *with laboratory* from Geography 108 or 108H with 108L; Science 100, 110, 120 with 120L, 130, 135, 140, 145 or 145H with 145L, 150, 160, 170 with 170L, 200, 220 or 240; and

**Social Sciences:** One 3-unit transferable course from Anthropology (except Anthropology 235); Economics; History; Political Science; Psychology (except Psychology 235); or Sociology (except Sociology 235).

One of the following 3-course sequences:

French 100, 101 and 200 (French 201 highly recommended) or Japanese 100, 101 and 200 (Japanese 201 highly recommended) or Spanish 100, 101 and 200 (Spanish 201 highly recommended).

**Note:** Students electing to begin American Sign Language (100 and 101) at Marymount College to meet this competency will be required to complete the language requirement at a college or university offering intermediate level.

One course from among: Math 110 (or higher level Calculus course); Anthropology 235, Math 270, Psychology 235 or Sociology 235; or Philosophy 130 (CAN PHIL 6)

One course from among the following: English 175, Women in Literature; or Interdisciplinary Studies 140, Images of Women in Literature and the Arts

One course to be completed at The Claremont Colleges from the list of courses approved to meet the Race and Ethnic Studies requirement
